### Tristone Group celebrates 20 years of Walbrzych plant / investment in additional building

Tristone Flowtech Group located in Frankfurt/M. announces the celebration of the 20 years anniversary of their plant in Walbrzych, Poland.

For this special occasion there has been organized a picnic for the employees and their families. The management board used this occasion to distinguish employees, which are working in the plant since its very beginning, who contributed to creating the image of the company in the last 20 years.

The anniversary constituted not only a great occasion to summarize our achievements to date; moreover, it was an impulse to take new and brave decisions as well as to implement long-term plans. Robert Proce, director of the Walbrzych plant, emphasized all the changes that have taken place since 1998 in terms of both the number of employees, and the profile of production currently in place. Nowadays, the company focuses on development of applications for cars with electric and hybrid drives. When the plant began its operation in 1998, only combustion engine applications were produced. The director underlined that the plant has been successful in Walbrzych for 20 years thanks to the people, who create a fantastic team and plant spirit.

In additional Walbrzych plant announced their expansion with building of a new production hall. The new hall will create additional space of 500 m<sup>2</sup> for central laboratory needs; also, there will be the production of plastic pipes located used in cooling systems for hybrid and electric cars for customers like Volkswagen Group, Volvo, BMW, Renault and Daimler.

The additional production and storage space will come to 2500 m<sup>2</sup> by an investment of 2 million Euros. The planned finishing of works is scheduled for the end of 2018.

The Group was established based on a spin-off of the former Fluid Automotive Business Unit of Trelleborg AB in July 2010 and is supplying to the automotive customers Renault, Nissan, PSA, FiatChrysler, Ford, Changan Ford, Volvo, General Motors, VW Group, Suzuki, BMW, Daimler, Jaguar Landrover, Suzuki, Mahindra-Mahindra, Bosch as well as further Tier I suppliers. Effective February 22, 2017, the Group was purchased by the chinese Zhongding Group, Ningguo and will continue to be managed under the same name and corporate structure.
